

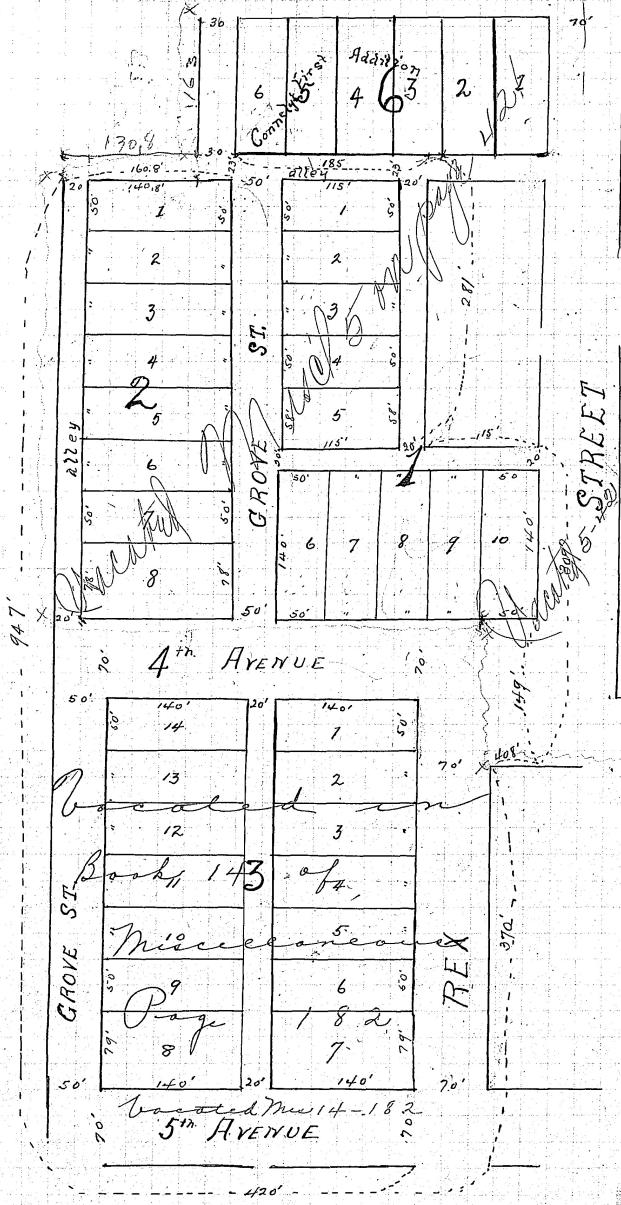

Meridian and more particularly as follows, to-wit: Commencing at a point 23 feet due ~~West~~  
South of the South West Corner of Lot 6 of Block 6 of Cornelly's 1st Add. to Egeland thence run West  
at right angles to the west line of lot 6 a distance of 1608' thence south at right angles a distance of 947 feet  
thence east at right angles a distance of 420 feet, thence north at right angles a distance of 370 feet, thence
