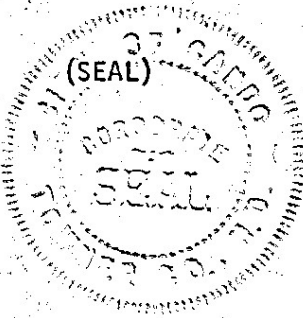

RESOLUTION TO ANNEX CANDO SUBDIVISION NO. 2-1980
TO THE CITY OF CANDO, NORTH DAKOTA

BE IT RESOLVED by the City Council of the City of Cando, North Dakota, as follows:

1. That the City Council of the City of Cando hereby determines that the property as hereinafter described in sub-paragraph 2 of this resolution is adjacent and contiguous property to the City of Cando and subject to annexation to the City of Cando and the City of Cando hereby adopts this resolution pursuant to Section 40-51.2-07 of the North Dakota Century Code proposing the annexation and annexing said territory to the City of Cando.

2. The property description of the property to be annexed is hereinafter described as follows:

An annexation description for a part SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 20, T158N, R66W of the 5th Principal Meridian, Cando, North Dakota described as follows:

Beginning at the northwest corner of Lot 20, Block 1, Arrow Addition to the City of Cando, North Dakota; thence southerly along the west block line of said Block 1, Arrow Addition, and the west block line of Arrow 2nd Addition to the City of Cando and its prolongation to a point on the centerline of North Dakota Highway No. 17; thence westerly along the centerline of North Dakota Highway No. 17 to a point of tangency; thence continuing westerly along the tangent of a 1°47' curve for a distance of 267.6 feet to the point of intersection and the southerly $\frac{1}{4}$ corner of said Section 20; thence northerly along the north-south quarter line of said Section 20 for a distance of 893.0 feet to a point on the south right-of-way of Sixth Street; thence easterly along the south right-of-way line of Sixth Street for a distance of 396.0 feet to the point of beginning, containing 7.4 acres more or less.

Said annexation shall be all of the above described land excluding the right-of-way of North Dakota Highway No. 17.

3. That heretofore attached and made a part by reference hereof is a map of the City of Cando showing the proposed property to be annexed.

4. The City Auditor is hereby authorized and directed to cause this resolution along with a map of the proposed area to be annexed to be published once each week for two consecutive weeks in the official newspaper of the City, and the owners of any real property within the territory proposed to be annexed shall be afforded the opportunity to file a written protest with the City Auditor protesting against the proposed annexation, at any time within thirty (30) days after the first publication

of this resolution, and the City Council shall at its next meeting after the expiration of said period, to-wit: On February 2, 1981, at 8:00 o'clock P.M., meet at the City Offices in the City of Cando, for the purpose of hearing and determining the sufficiency of any protests so filed and of taking such further action with respect to said annexation as may then be deemed necessary and expedient.

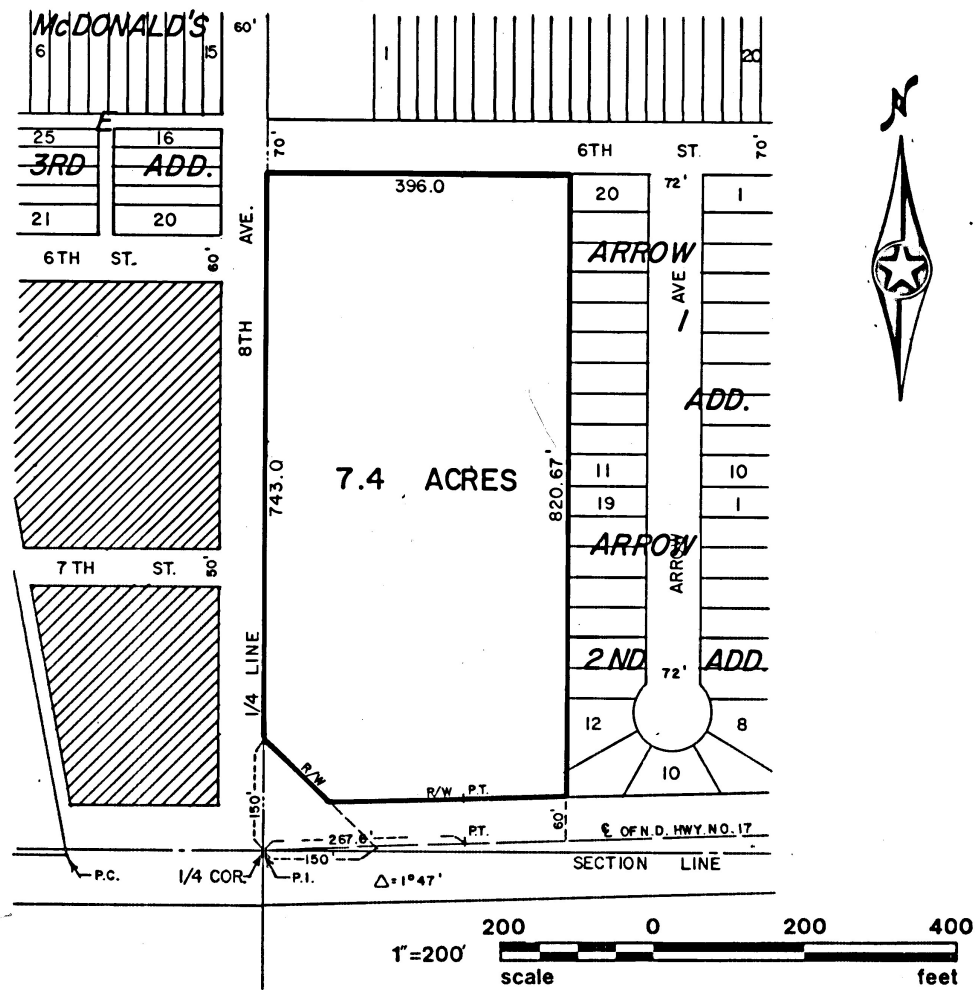

Beginning at the northwest corner of Lot 20, Block 1, Arrow Addition to the City of Cando, North Dakota; thence southerly along the west block line of said Block 1, Arrow Addition, and the west block line of Arrow 2nd Addition to the City of Cando and its prolongation to a point on the centerline of North Dakota Highway No. 17; thence westerly along the centerline of North Dakota Highway No. 17 to a point of tangency; thence continuing westerly along the tangent of a 1°47' curve for a distance of 267.6 feet to the point of intersection and the southerly $\frac{1}{4}$ corner of said Section 20; thence northerly along the north-south quarter line of said Section 20 for a distance of 893.0 feet to a point on the south right-of-way of Sixth Street; thence easterly along the south right-of-way line of Sixth Street for a distance of 396.0 feet to the point of beginning.
