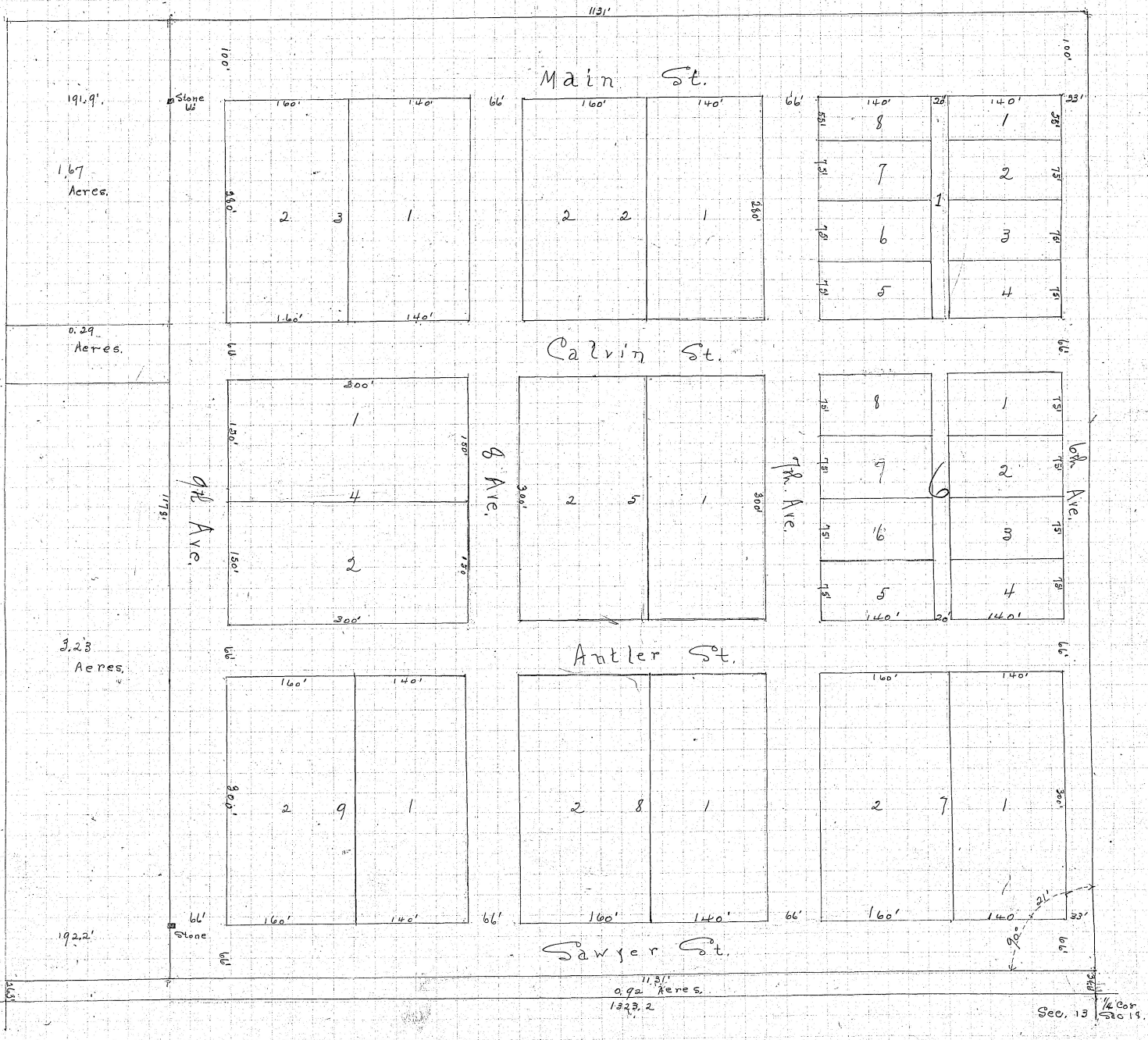


Plat of the Third Addition to Sables, N. D.

Know All Men By These Presents: That we, the undersigned, are owners in fee simple of the following described property, situated in section thirteen (13), town one hundred and sixty three (T. 163), range sixty five (R. 65), Towner County, North Dakota, to wit: Commencing at the south west corner of the Second Addition to Saled, North Dakota, the same being on the line between ranges sixty four and sixty five (R. 64 and 65), and thirty four and six tenths feet (34.6) north of the one quarter corner of section thirteen, town one hundred and sixty three, range sixty five (sec. 13, T. 163, R. 65), Towner County, and section eighteen, town one hundred and sixty three, range sixty four (Sec. 18, T. 163, R. 64), Cavalier County, North Dakota; thence North on the line between said sections, one thousand one hundred and seventy eight feet (1178'); thence west at an angle of ninety degrees and twenty one minutes (90°21') one thousand one hundred and thirty one feet (1131'); thence South at an angle of eighty nine degrees and thirty nine minutes (89°39') one thousand one hundred and seventy eight feet (1178'); thence east at an angle of ninety degrees and twenty one minutes (90°21') one thousand one hundred and thirty one feet (1131') to point of commencement; more over, that we have caused the same to be surveyed for the purposes of a townsite, and the annexed ^{plat} and description thereof to be made and designated as shown, and that we hereby dedicate to the public use forever all streets and alleys shown upon this plat.
