BE IT RESOLVED by the City Council of the City of Cando, North Dakota, as follows:

1. That the City Council of the City of Cando hereby determines that the property as hereinafter described in sub-paragraph 2 of this resolution is adjacent and contiguous property to the City of Cando and subject to annexation to the City of Cando and the City of Cando hereby adopts this resolution pursuant to Section 40-51.2-07 of the North Dakota Century Code proposing the annexation and annexing said territory to the City of Cando.
2. The property description of the property to be annexed is hereinafter described as follows:

A tract of land lying and being in the Northwest Quarter (NW $\frac{1}{4}$) of Section Twenty (20), Township 158 North, Range 66 West, more fully described as follows:

Beginning 20 feet West of the Southwest corner of Thom's Addition to the City of Cando, according to the plat thereof on file and of record in the Office of the Register of Deeds of Towner County, North Dakota; thence West a distance of 78 feet to the Southeast corner of Thom's 3rd Addition to the City of Cando; thence North a distance of 160 feet to the Northeast corner of said Thom's 3rd Addition; thence East a distance of 78 feet to a point 20 feet directly West of the Northwest corner of Thom's Addition to said City of Cando; thence South a distance of 160 feet to the point of beginning. Contains 0.29 acres, more or less.

3. That heretofore attached and made a part by reference hereof is a map of the City of Cando showing the proposed property to be annexed.
4. The City Auditor is hereby authorized and directed to cause this resolution along with a map of the proposed area to be annexed to be published once each week for two consecutive weeks in the official newspaper of the City, and the owners of any real property within the territory proposed to be annexed shall be afforded the opportunity to file a written protest with the City Auditor protesting against the proposed annexation, at any time within thirty (30) days after the first publication of this resolution, and the City Council shall at its next meeting after the expiration of said period, to-wit: On June 20, 1977, at 8:00 o'clock P.M., meet at the City Offices in the City of Cando, for the purpose of hearing and determining the sufficiency of any protests so filed and of taking such further action with respect to said annexation as may then be deemed necessary and expedient.
