KNOW ALL MEN BY THESE PRESENTS; that, Tri-State Land Company, a Corporation organized and existing under the laws of the State of Minnesota, the owner and proprietor of that certain land situated in the County of Towner and State of North Dakota, and being all that portion of the West Half of that North West Quarter of Section Six (W 1/2 of NW 1/4 of Sec 6) in Township One Hundred Fifty-Nine (159) North of Range Sixty-Five (65) West, and the East Half of the North-East Quarter of Section One (E 1/2 of NE 1/4 of Sec 1) in Township One Hundred Fifty-Nine (159) North of Range Sixty-Six (66) West, described as follows to wit:

Beginning at an iron monument located at the South East Corner of the Townsite as now platted, thence West along the Southern boundary of the present Townsite a distance of 1325 feet to an iron monument forming the South West Corner of the Townsite as now platted, thence to the left at right angles a distance of 370 feet to an iron monument, thence to the left at right angles a distance of 370 feet to an iron monument and thence to the left at right angles a distance of 370 feet to the place of beginning.

Has caused the same to be surveyed platted and hereafter known as Blocks 20, 21, 22, 23, and 24 in the Town of EGELAND, and hereby donates and dedicates to public use all the streets, avenues and alleys thereby shown.
