Beginning at a point 300 feet East of the South East Corner of Lot 12 Block 3 of Percival and McDonald's Addition to the Town of Cando. thence running South 440 feet parallel with the Great Northern Railway thence East 420 feet. thence North 960 feet thence West 541 feet thence South 520 feet to the place of beginning.

First Street Second Street Main Street and Hill Street are 60 feet wide. Park Avenue is 80 feet wide. all Alleys are 20 feet wide. Lots 2 to 5 in Block A are 25 feet by 140 feet. 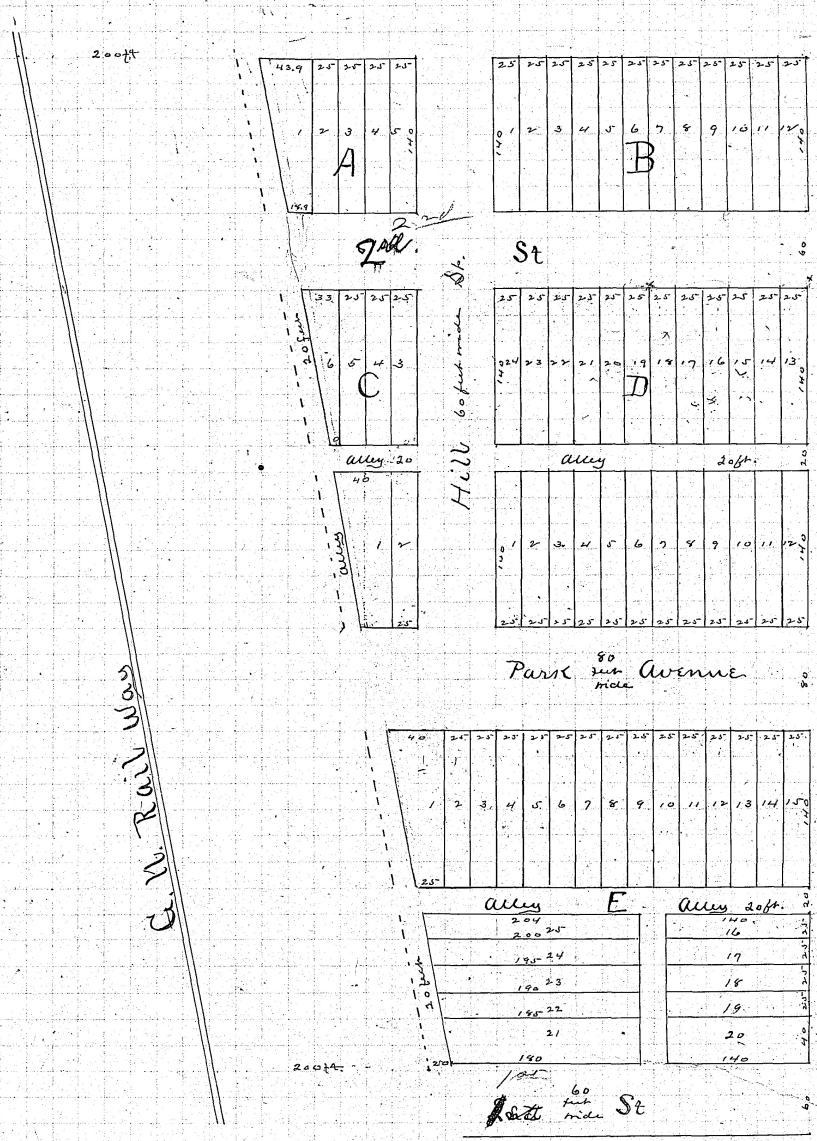
