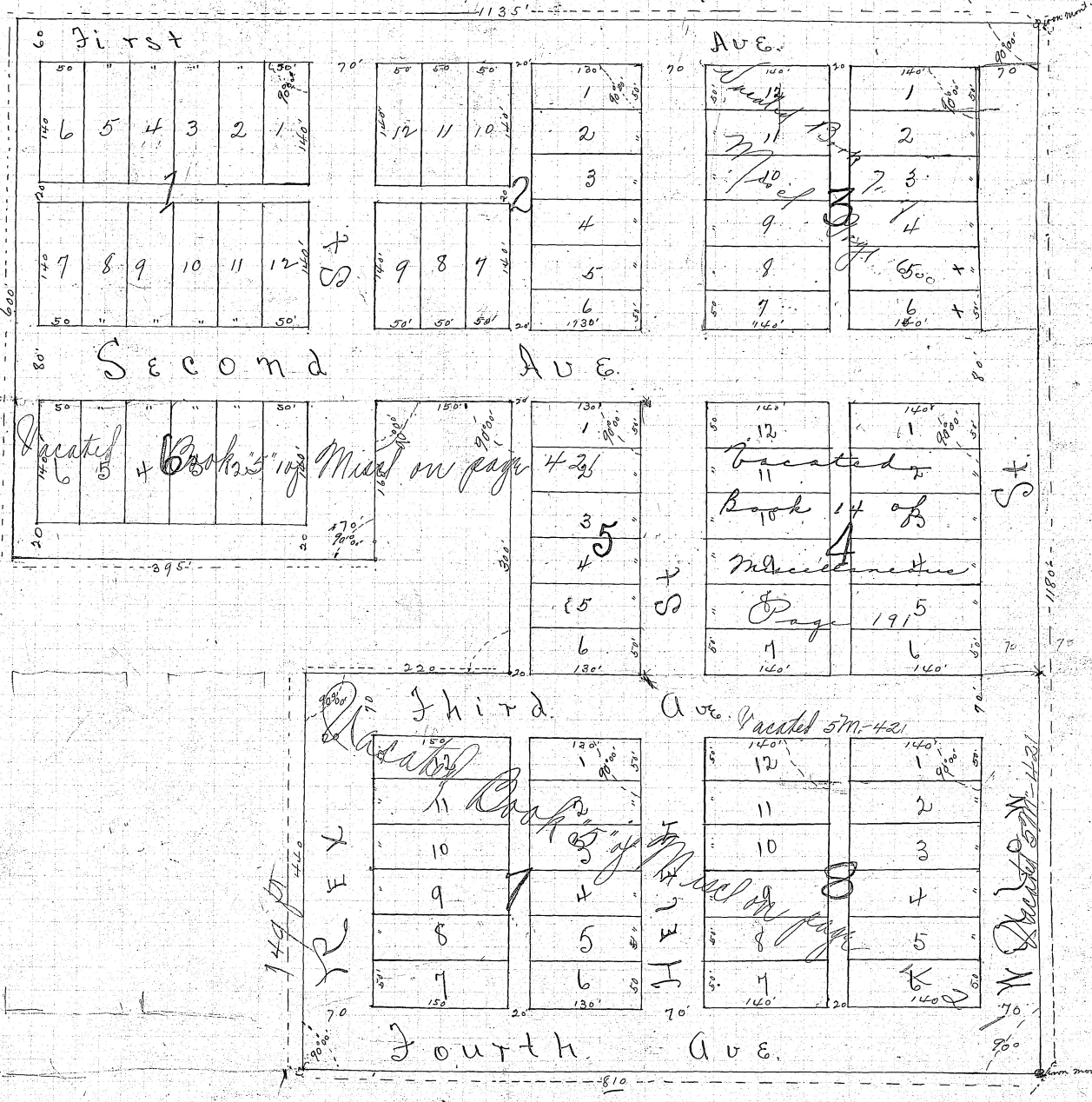


PLAT OF *Connely's Add to Egeland, Egeland N D* TOWNER COUNTY, N. D.
