



I P. J. Hard do hereby certify that I have made an accurate survey of the land represented in the accompanying plat to be known as the Town of Perth. The same being a portion

of the North East Quarter of Sec. Five, Township 160 North of Range 68 West described as follows Beginning at the North West Corner of the above mentioned quarter section thence East on the Section line 220 feet to the G. N. P. R. Co Right of way, thence South East 1191 feet and 10 inches along the right of way of the above mentioned railroad to a stone monument marked thus E.C. Place of beginning said monument has in it 1008 cubic inches of stone, thence South West in the direction indicated by the accompanying plat 872 feet to a stone monument having in it 1155 cubic inches of stone and marked thus W.C. The line from the first to the second monument is the base line of this plat thence North parallel with the West North and South Quarter line of the above mentioned quarter sec 576 feet thence North East in the direction indicated by the accompanying plat 588 feet to the right of way of the G. N. P. R. Co thence South East 490 feet along said right of way to the stone monument place of beginning as shown by accompanying plat.

I have advised said monuments to be planted deeply in the ground to remain as witness stands forever. Main street is eighty feet wide all other streets are 60 feet wide except First Street which is 25 feet wide and Third Street which is 25 feet wide, all alleys are 20 feet wide, all lots on said plat are 25 feet front by 130 feet deep except Lot 1 in Block 1 which is 84 feet deep in a shape and Lot 1 in Block 5 which is 63 feet front by 110 feet deep in a shape and Lot 5 in Block 5 which is 77 feet front by 125 feet deep in a shape.
