ORDINANCE NO. 232

An ordinance for the inclusion of Miller's Addition within the limits of the City of Cando, and for the extension of its territorial limits in accordance therewith.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CANDO, TOWNER COUNTY, NORTH DAKOTA, AS FOLLOWS, TO-WIT:

Section 1. That the tract of land lying contiguous with the limits of the City of Cando, Towner County, North Dakota, and more fully described as follows, to-wit:

A tract of real property lying in the Southeast Quarter (SE 1/4) of Section Twenty (20), Township 158 North, Range 66 West of the 5th Principal Meridian, Towner County, North Dakota, and described as follows:

Beginning at a point 70 feet North of the Northwest Corner of Lot 1, Block 3, replat of Pete Bjornstad Addition to the City of Cando; Thence due North a distance of 170 feet; Thence due East a distance of 150 feet; Thence due South a distance of 170 feet; Thence due West a distance of 150 feet to the point of beginning. Said described parcel contains 0.59 Acres, more or less,

and which tract of land has been properly surveyed, laid out, and platted into lots, streets, and alleys, as Miller's Addition to the City of Cando, Towner County, North Dakota, all as shown by the certified plat thereto herewith attached and made a part hereof; be, and the same hereby is, included within the territorial limits of the City of Cando, to be known as "Miller's Addition to the City of Cando", and further, that the territorial limits of said City of Cando be, and they hereby are, extended to include said territory and addition.

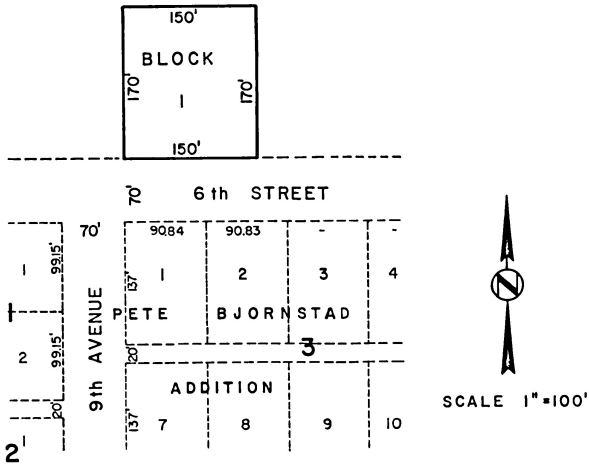
